Program Overview

Harvest After School provides a safe, fun, caring, Christian-based environment for students. Daily scheduled homework/study/reading times are offered, as well as snacks and daily opportunities to socialize with peers.

Admission/Tuition

- Harvest After School is available to elementary and middle school students.
- Due to staffing and licensing restrictions, enrollment is on a first-come, first-served basis.
 - A waitlist will be established when the program is full.
- Your child must have the NYS-required immunizations to be admitted.
- Costs and fees are as follows:
 - Tuition: \$3,500.00 for the school year
 - Transportation costs: \$500 for the school year
 - Non-refundable registration fee, due upon initial enrollment: \$50
 - Waived for return students
- Our program currently offers the following discounts:
 - Existing Student Discount: \$100.00 off
 - End of Year Discount: \$350.00 off
 - Expires 7/4/2024
- All fees are due 30 calendar days before the start of the semester.
 - Students will be withdrawn from Harvest After School if tuition is not received within 30 days of the due date.
- A \$25 late registration fee will be applied if a student is enrolled after the start of the school year.
- The structure of refunds upon withdrawal is as follows:
 - 14 days before the first day of the school year, 50% of payments made will be refunded
 - 7 days before the first day of the school year, 25% of payments made will be refunded
 - No refunds will be available after the school year has started
- Transportation is available for schools within 5 miles of Harvest After School.
 - Restrictions may apply due to availability.
- Harvest After School ends at 6:00 PM. In the event it is past the 30-minute grace period (6:30 PM) and your child has not yet been picked up, a \$20 late pick-up fee will be applied (applicable for each time). (To be billed monthly.)

Health/Safety

- Following the NYC Department of Education, parents are responsible for implementing immediate pick-up arrangements in the event their child is sick.
 - This includes signs and symptoms of fever, vomiting, head lice, and other infectious diseases.
- Parents must inform Harvest After School of any special health care needs his/her child may have.
- Children are encouraged to bring a change of clothes (in case of an accident or emergency).
- Parents will be notified immediately in the event of an illness or serious injury.
- The registration form that parents are required to complete upon their child's enrollment in Harvest After School includes parent permission for emergency medical treatment for their child.
 - This includes providing first aid and calling 911 for medical assistance in the event the illness or injury is severe.

Health/Safety (continued)

- In the event a child is taken directly to a hospital, a staff member will accompany the child. Parents will be notified as soon as possible.
 - Parents will also be responsible for any medical fees incurred.
- Medications will only be administered if it is required under provisions of the Americans with Disabilities Act (to be determined on a case-by-case basis).

Allergy and Anaphylaxis Policy

- Harvest After School is a peanut-free program. Children are prohibited from bringing peanut products with them to the program.
- Parents must provide written notice from a doctor/physician for students requiring an epinephrine autoinjector (EpiPen). Parents must also provide an injector for the student (to be left with Harvest After School staff) in case of emergency.

Daily Routine and Homework Support

- Students begin arriving following their school's dismissal time. (Those registered for transportation are picked up and brought back to Harvest After School.)
- Shortly after arrival, a light snack is served, and the groups have a chance to socialize.
- Students will promptly begin homework after snack is completed and work until all his/her assignments are complete. Those who do not have homework may do other quiet activities such as reading, drawing, etc. so long as it does not create a disturbance for students who are still working.
- Free Time officially begins forty minutes after homework time has begun and is only open for students whose homework has been completed. During this time, students will have a chance to socialize and play.
 - Play may be outside, weather permitting.
 - Students who have not yet finished their homework will have the opportunity to join the activities after they've finished their work.
 - For students who take a long time to finish their work, there is no rush. They can work comfortably until they are picked up.

Program Schedule/Scheduled Early Dismissal Days

- Harvest After School will follow the school district calendar by operating on all full school days.
 - Upon special request, Harvest After School can be available to students on early dismissal days for an additional \$20 per day.
- Please take a look at our Important Dates Calendar for the days the program will be closed.
 - This does not include "snow days" or days when school buildings are closed due to an emergency.

Social Media, Electronics, Personal Belongings:

- Apart from academic purposes, students are not permitted to use electronic devices (ie: cellphones, iPads, gaming devices) during program hours.
- If you need to get in touch with your child during program hours, please contact our office.
- Harvest After School is not responsible for the loss or damage of personal items brought from home to the program.

Pick-Up

- Harvest After School requires all parents/guardians/designated pick-up persons to be listed on the student's enrollment paperwork.
- A copy of a Photo ID will be kept on file for all designated pick-up persons.
- If a child resides in two separate households with their custodial parents, Harvest After School will require that each parent's information is indicated on the registration form.
- Harvest After School ends at 6:00 PM. In the event it is past the 30-minute grace period (6:30 PM), and your child has not yet been picked up, a \$20 late pick-up fee will be applied. (To be billed monthly.)
- Parents or other designated pre-authorized adults (age 18 or older) are responsible to escort and sign out for the program each afternoon.
- Photo ID will be required to be presented by authorized individuals if they are unknown to the staff.
- Harvest After School will not release a child to a parent or designated pick-up person if, in the judgment of the staff, the person is acting in a way that is consistent with the inappropriate use of drugs or alcohol. (While we cannot hold a child against his/her parent's will, Harvest After School staff will be required to contact the local police and CPS.)
- Unauthorized persons (anyone who is not listed on the emergency contacts or registration application) will not be permitted to pick up a child.

Contact and Communication

- Please add the Harvest Church of New York phone number, Harvest After School Office number, and Harvest After School e-mail address to your phone contacts.
- It is important to leave a message in the event there is a schedule change or if you will be late to pick up your child.
 - In the event it is closing time and we have not heard from you, our office will call all of the phone numbers provided on your registration form, including all emergency contacts.
- Please immediately notify Harvest After School of updated phone numbers, home addresses, workplaces, authorized pick-ups, custody arrangements, health issues, or any other changes.
